

Inquiry

Why we need more funds

As many of you know, the inquiry that was postponed last year is due to resume on 4th April.

The landowner and the quarry company have employed top-flight QCs to fight their case. On the other side the Peak Park has a QC and we with the CPRE can continue with our advocate if we can raise more funds.

Having seen the opposition's QCs in action at the pre-inquiry meeting held last week we are in no doubt that the power of their advocacy may well win Bleaklow and MMC the appeal against the Peak Park's enforcement notice. This could in effect open up a great swathe of Longstone Edge for massive quarrying.

The money you donated so generously in the past has been spent on technical planning advice preparing for the inquiry, but little is left over for representation at the now greatly extended inquiry itself. However, without an advocate neither SLEG nor CPRE will be able to examine or cross question the appellants. We feel that the Peak Park's QC on her own cannot save the day.

We have fought the battle of Longstone Edge for so long now it would be tragic to lose the day for want of representation.

Rape stopped

The Park Authority finally served a Stop Notice at Backdale, effective 29th January, the result of great lobbying by all of us and hard work by the committee – a brilliant result.

The effect is to stop the breaking of new stone – blasting should stop – but processing of loose stone and selling from stockpiles can continue.

But the main thing is that the destruction has been halted.

We shall keep a close eye on the quarry to check there's no backsliding.

What does the Stop Notice mean?

Please do not think this is the end of the matter. The Stop Notice just stops the destruction until the inquiry reports in the Autumn – or later if there's a high court challenge.

Therefore winning the inquiry remains the all-important task. Were we (and the Park Authority) to lose this, the operators would have a free hand to start quarrying up on the top of the Edge, AND claim compensation for loss of profit from the stop notice.

Recent Events

- Nov 28th AGM, Village Hall, Calver.
 A packed house lets the people from the Park Authority take away a grasp of everyone's deep hurt and sense of injustice at what is happening at Backdale. Many of those attending write to landscape minister Jim Knight, and we send our high impact DVD to him and to Park Authority members.
- Dec. We commission a report on options available, and engage with the Park to discuss the way forward.
- Dec/Jan. The Park, now with a stop order in mind, meets government seeking support in the form of financial indemnity against potential compensation claims from the landowner and operator if the inquiry went in their favour. They get indications of assurance.

Please give enclosed leaflets to your friends

- Dec/Jan. During this period we had alerted the media and many articles appeared in local and national press, and on TV news programmes, including Channel Four, Calendar and BBC. The pressure was building.
- Jan. In a final push, we lobby Margaret Beckett who would have the last word. Government gives its assurance.
- 20th Jan. The Park Authority resolves to serve a stop notice, effective 29th January.
- 30th Jan. Jim Knight visits Backdale for first hand impressions. We waylay him on the footpath opposite the quarry and a media scrum results with three TV crews radio and print journalists vying for his attention.
- 30th Jan. Packed Cliff College meeting hears Park's account of events and we reinforce our views.
